## LEADERSHIP INSTITUTE DEVELOPS WATER MANAGEMENT KNOWLEDGE & EXPERTISE

Residents of disadvantaged rural communities in California's San Joaquin Valley often find it challenging to participate and effectively lead their communities in regards to water quality and quantity issues that they face.

**To help build leadership capacity and gain water management tools, Self-Help Enterprises' Community Engagement and Planning team launched the first-of-its-kind 2019 Rural Communities Water Managers Leadership Institute for community water board members and staff, water leaders, and residents from rural communities.**

The six-month Leadership Institute program, offered at no charge thanks to the generous support from the Central Valley Community Foundation, USDA Rural Development, and the State Department of Water Resources, took place from March through August 2019 with sessions held one Saturday per month. Through bilingual trainings, workshops, and an educational tour, water leaders from disadvantaged communities gained the skills and knowledge to effectively participate in regional water management and planning programs, such as the Sustainable Groundwater Management Act (SGMA) and the Integrated Regional Water Management (IRWM) program. The Leadership Institute will also establish a cohort of participating communities throughout the San Joaquin Valley.

Thirteen residents, known as Cohort 1, from 10 disadvantaged communities in Fresno, Tulare, Kings, and Kern counties graduated the 2019 Leadership Institute. To date, the Leadership Institute has trained more than 60 new water leaders.

# LEADERSHIP INSTITUTE CURRICULUM

To develop the Leadership Institute curriculum, SHE conducted an intentional stakeholder scoping process through three focus groups and surveys to capture the needs and topics of interest from community residents. This culminated in the “Stakeholder Perspectives and Recommendations” Report and the 2019 Rural Community Water Managers Leadership Institute.

Through classroom instruction, group activities and a water tour, the curriculum enhanced leadership skills, increased participants’ knowledge about water resources water management programs and prepared participants to engage in important groundwater management planning and implementation efforts taking place within their region.



During the six-month program, curriculum topics explored included:

## **Session 1: March 2019**

Topics: Water Conditions in the Central Valley, Introduction to Water Management and Planning Programs, and Community Participation in Water Management Programs

## **Session 2: April 2019**

Topics: State Water Management-California Water Laws and Regulations, Understanding Stakeholder Interests and Political Dimensions of Water Management, and Water Management and Planning Programs

## **Session 3: May 2019**

Topics: Funding Programs and Requirements, Site Visit of IRWM Funded Project, Project Development and Working with Engineers and Consultants

## **Session 4: June 2019**

Topics: Presenting Information to Your Community/Board, How to Prepare for and Participate in Meetings, and Consensus Building

## **Session 5: July 2019**

Topics: Water Sources, Uses, and Users Water Tour

## **Session 6: August 2019**

Topics: Policy and Legislative Advocacy, Building and Sustaining Community Power and Partnerships, Diversifying California Water Management, and Graduation



# WATER TOUR HIGHLIGHTS WATER SOURCES, USES, AND USERS



On July 20, 2019, Leadership Institute participants, guests from rural communities, and staff from Self-Help Enterprises (SHE) partook in a water tour that highlighted common water needs, current projects underway and discussed ways communities could work together to address water quality and access in the region. Tour stops included the following locations and presenters:

- **SBS Ag, Farm and Dairy in Tulare, CA**

Presenter Blake Wilber, committee member of the Mid-Kaweah Groundwater Sustainability Agency Advisory Committee member and partner at SBS Ag, shared how they conserve water for their farm and dairy operations by leveraging resources including solar power, reducing waste, and using a drip irrigation system to farm in a more sustainable way.

- **Okieville Highland Acres Mutual Water Company**

Presenters Maria Martin and Maria Marquez, Board Members of the Okieville Highland Acres Mutual Water Company, informed how the recent drought led to dry wells in the community. With support from SHE, the community received \$2.5 million in emergency grant funding from State and Federal sources to drill a new community well and construct a distribution system.

- **Farmersville Sports Park**

Presenter Paul Boyer, Farmersville City Council Member, shared how the sports park is designed to provide a space for the community as a recreational facility as well as provide benefits to the environment including small amounts of water recharge.

- **Oakes Basin**

Presenter Mark Larsen with the Kaweah Delta Water Conservation District (KDWCD) informed that the Oakes Basin was constructed for the purpose of groundwater recharge, stormwater layoff and habitat mitigation.

- **Packwood Creek Structure**

Presenters Mark Larsen and Shane Smith with KDWCD shared how the project is focused on maximizing water storage and recharge capabilities in Packwood Creek.

# JOIN THE 2020 LEADERSHIP INSTITUTE



Self-Help Enterprises (SHE) will be recruiting water leaders, water board members, staff and residents from disadvantaged communities to participate in the 2020 Rural Communities Water Managers Leadership Institute. Disadvantaged communities have been disproportionately represented on the boards and committees of regional water management and planning programs, such as the Sustainable Groundwater Management Act (SGMA) and the Integrated Regional Water Management (IRWM) program. As water management and planning programs become a significant focus for other water interests that have more resources, it is critical that water leaders, water board members, staff and residents from disadvantaged communities are given the tools and resources necessary to improve their participation in these programs and represent the interests of their community.
